IBSA Workshop Terms and Conditions

- 1. Registration fees must be paid prior to attendance at a workshop. Registrants who find that they are unable to attend a workshop may nominate a substitute to replace them at the workshop
- 2. Delivery of a workshop by IBSA will be dependent upon a minimum number of registrations being received.
- 3. IBSA reserves the right to vary the date of a workshop if insufficient registrations are received.
- 4. Cancellation policy
 - a. In the event that IBSA cancels a workshop event registration fees will be refunded in full, or can be carried forward to a future event.
 - b. A registrant who cancels registration more than seven days before the date of a workshop event will receive a full refund of the registration fee.
 - c. A registrant who cancels seven days or less before the date of a workshop event will receive a 50% refund of the registration fee.
 - d. No refund will be made for non-attendance on the day where prior notification of non-attendance was not received by IBSA. Registrants who are unable to attend may nominate a substitute to replace them at the workshop.
